Sir,

With due respect I would like to report a cognizable offence carried out against me and my families on 04th May at around 4:00 pm, wherein, a large gathering a mob of mainly Meltel Community who were suspected to be instigated and abated by Meltei Leepun & Arambai Tenggol of Valley based CSO's attack on my/our village Phainom Veng and started Vandalizing, ransacking and burnt down my/our properties rendering me in a state of homeless person. Fearing to lose our lives and being in state of vulnerable, me along with my family/villagers numbering Male and Female had fled and now taking refuge and shelter at the resident/relief camp of ICI office (Kangpokpi Dist) .
