Sir,

With due respect, I the undersigned have the honour to state that on 25/07/2023 at around 05:30 am, one Tata driver Pankaj Kumar (driver of vehicle Tata LPT 1512 bearing registration No. AS25EC-4919 hired by East India Transport Agency) informed me that he along with the Tata truck went for unload the goods loaded with 179 Nos. of mixed goods under Manifest No. GHT/0192601 which was dispatched from Guwahati to Imphal, dtd. 11/07/2023 at the godown located at Koirengei. On reaching the godown he came to know that the Tata Tripal (Cover) was found tear on the back side of Tata truck and suspected to be stolen some goods which were loaded inside the truck. The incident was supposed to be done at the midnight of 24/07/2023 while the Tata truck was parked at Khabam Lamkhai area, IE. Thereby, I paid a visit to the godown located at Koirengei for inquiry regarding the incident and found the same. After checking the physical availability of goods by unloading from the Tata truck in which 42 Nos. of packets of C.P. goods were found missing from the actual Nos. of Packets mentioned above. The approximate value of the missing C.P. goods is about 10,00,000/- (ten Lacs).

It is therefore, requested you to kindly take up necessary legal action.
