With due respect, I have the honour to state that, on the 4<sup>th</sup> May 2023, at around 11:00 PM, miscreants belonging to Meitel community numbering more than 500 people suspected to be members of Armbal Tenggol and other Extremist volunteers by holding various deadly weapons attack our locality i.e. K. Vengnom, Mantripukhri, PS-Heingang, Imphal East, Manipur. In the incident, the miscreants have attacked at my rented house (House owner-Wilson Mate), vandalized and looted all the household property from my house. The looted household properties are Furniture, Kitchen and Utensil items, clothing and Garments, Electronic items and other valuable assets.

The approximate amount of vandalized and looted properties are estimated at Rs. 10,00,000/- (Ten lakhs) only.

The incident could not be reported immediately due to insecurity of our lives and volatile situation of the area.

I, therefore request you to kindly take up necessary action against the miscreants involved in the commission of the crime.
