Subject :- Report on attempt to murder/crimes of vandalism, looting and burning of properties/discrimination of Scheduled tribes.

Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows :

That, I am a Scheduled Tribe belonging to the Vaiphei Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, my wife along with my children left our residential house located at Mantripukhri near IGAR South, PO/PS- Heingang on the 4th of May, 2023, at around 4:30 PM during my absence as I was out stationed on duty in Tinsukia, Assam serving under 68th Battalion of CRPF as a Sub-Inspector. And, it has come to my knowledge that our deserted resident was attacked, destroyed, looted and burnt by a group of radical Meitei/Meiteis suspected to be members of Arambai Tenggol and Meitei Leepun on the 29th of June, 2023 at around 3:00 PM.

The criminals broke open my gate, destroyed and looted every valuable property from my house/premises worth about Rs. 33,00,000/- (Rupees Thirty Three Lakhs) only.

That, it may be reported here that the miscreants were shouting slogans like – "KANGLEIPAK YAIPHARE", "KUKI HATLO", "HAO HATLO" etc while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Govt. as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of Manipur Govt are patronizing them that on harm could be done to them.

That, on the intervening day my gearless-scooter (Type – two wheeler, colour-Black, mark&model – Hero Pleasure Plus, B/No. A/F newly purchased) was also torched by the above mentioned miscreants worth Rs. 96,000 (Rupees Ninety Six Thousand) only. Therefore, I would also like to add that I have kept my Four-wheeler (Tata Tiago, Colour-White, B/Regd. MN01AK4770) in the care of the 4th Assam Rifles, Mantripukhri, IGAR South, along with the vehicle Key on the 1st of July, 2023.

I, Therefore, request you to kindly register my case and take stern action against the perpetrators under the relevant provision of law of our country.
