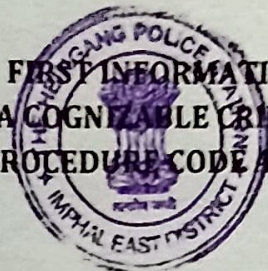

Sir,

I have the honour to report that I am in possession of a house with semi-pucca construction at K. Vengnom near IGAR South Campus Mantripukhri, Imphal.

The details of the said house are as given below:

- (1) Patta/Jamabandi No. – 282(Old) – 67/636 (new)  
Dag No. 142-900(Sht-I)-005 Khabam, Imphal.  
Area - .02428 Hectare.

I and my family have been compelled to leave that said house with all our belongings like furniture/clothes/ electrical/electronic appliances/crockeries etc on 4<sup>th</sup> May, 2023 as communal riot and violence erupted in Imphal. And, it has come to my knowledge that, on 14<sup>th</sup> May, 2023 at around 11:00 am all the properties we left behind have been vandalised and looted by miscreants suspected to be from Meitei community.

The matter could not be reported at my concern PS and in time due to the prevailing law and order of the state.

I, therefore request you to kindly take necessary action in this regard.
