That, on the 03rd May, 2023 at 9:00 pm my above said residence (owned) was attacked, destroyed, looted by a group of Meitei/Meitei radicals.

These criminals broke open my gate(s), destroyed and looted every valuable properties from my "Owned" house and premises worth Rupees 16,641,500 (approx) and they burnt down all the remaining things.

That, while carrying out their above said criminal activities, the said Meitei radical groups were shouting anti tribal slogans like " HAO HATLO", KUKI HATLO". "KANGLEIPAK YAIPHARE" etc. hence, the same can be taken as an insult on me and my family for being a tribal.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an Zero FIR under relevant sections f the statutes of our country.
