With due respect, I the undersigned would like to make a report to your good office about the attempt to murder committed by Meitel mob while I was inside my room at CMC Hospital Hostel PO & PS mantripukhri District Imphal East on 3 rd May 2023.

At the very outset, I would like to draw a few line for your information that in the intervening day some mob (Meitei) entered our Ladies Hostel at around 7 :00 pm and they were searching for any Kuki/Zo people residing there while they were shouting anti slogans like "Hao Hatlo"/Kui Hatlo. Fortunately, I managed to escape from these criminals who tried to kill/burn me alive.

I request you to take strong actions against the perpetrator by registering a FIR/Zero FIR under criminals' provision of law.
