At the very outset, I would like to draw a few line for your information that in the intervening day some mob (Meitei entered our Ladies Hostel at around 7:00 pm and they were searching for any Kuki/Zo people residing there while they were shouting anti slogans like "Hao Hatlo"/Kui Hatlo. Fortunately, I managed to escape from these criminals who tried to kill/burn me alive.

I request you to take strong actions against the perpetrator by registering a FIR/Zero FIR under criminals' provision of law.
