Children left the house at around 8.30 pm and took shelter at Yangang pokpi Meitri house where one of my relatives house on 4/5/2023 along with my family members took shelter at Koirung hill 17/5/2023, then from 18/5/2023 along with my family members are taking shelter at Baramanga college relief camp till 10 days.
