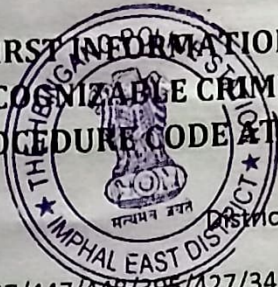

Subject :- FIR regarding miscreants who vandalized my house, vehicles looted gold, cash and properties on 04th May 2023 at Catholic Colony Mantripukhri.

Sir,

I would like to bring the following facts to your kind notice that,

- (i) There was a communal riot between Meiteis and kukis of Manipur on 03rd May 2023, so far many people have lost lives, properties and worship places have been burnt down.
- (ii) On 04th May 2023 at around 3:00 pm, miscreants from Meitei community vandalized my house and completely looted my belongings cost approximately Rs. 20,40,000/-
- (iii) I and my family members had to run for the safe of our lives to the nearest Assam Rifles IGAR South Mantripukhri without any spare cloths and bare necessities of life.
- (iv) House destroyed and list of looted properties are as follows :-
 1. WAGON R MN05A 6881 Approx value Rs. 3.5 lakhs
 2. Aactiva MN01U 2040 – Approx cost Rs. 90,000
 3. Furniture – Approx cost Rs 1.5 lakhs
 4. 3 Kingsize Bed, 2 Normal bed, 5 mattresses – Approx. Cost Rs 1 Lakh
 5. Inverter with 3 batteries – Approx cost Rs. 35,000/-
 6. 3 Trolleys and 2 suitcase – Approx cost Rs. 45,000/-
 7. 3 Godrej – Approx cost Rs. 22,000/-
 8. 11 Blankets Approx. Cost Rs. 22,000/-
 9. 5 Cylinder, Fridge, Washing Machine, Desktop Computer Set- Approx. Cost Rs. 79,000
 10. Traditional Shawl, Clothes and dresses – Approx. Cost Rs. 28,000/-
 11. Sintex and kitchen items – Approx. Cost Rs. 54,000/-
 12. Television – Approx. Cost 23,000/-
 13. 5 Bags of rice and 7 Big pots – Approx. Cost Rs. 9,000/-Total – Rs. 20,40,000/- (Twenty Lakhs and forty thousand only)

Therefore, I seek your help and kindly request you to register FIR in the subject matter and do the needful favourably at the earliest.
