Sir,

I, the undersigned, residing in the above mentioned address would like to lodge complaint against looting, vandalized of house building and theft during the last week of June, 2023.

That Sir, I would like to report that –

1. My house building (RCC) Construction on Homestead Land; bearing Patta No. 65/190, No. 7 Lamlongei, Heingang Tehsil, Porompat Sub-Division issued vide order No. Misc. 41/SDC/IE/H dtd. 13/02/2023, Name of Pattadar Asong Misao was Vandalised and my household items including Furnitures and Fixtures, Cookries and Crockery, laptoops, television, washing machine, microwave oven, mattresses, cloths and other essential and important items including personal and family documents were looted by rioters/looters during the last week of June 2023.
2. Further, a Maruti Alto K-10 car bearing registered No. MN03A-3178 registered by the name of Shri Asong Misao, parked in the compound was also stolen during the above mentioned period.
3. I would also like to report that Go-Down of M/S Misao Gas service situated in the same compound was vandalized by the rioters/looters.

Therefore, with the above facts and state of affairs, I would like to request you to lodge this FIR case and take stringent action as per the law of the law.
