

Sir,

With due respect, I the undersigned have the honour to state that today i.e. 28/07/2023 at around 03:00 pm, a combine team of CDO/IE led by ASP(Ops) Shri N. Herojit assisted by SI Nongallakpa Yumnam CDO/IE team and one team of HNG-PS led by ASI Md. Akbar Shah along with four team of CDO-IE under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP/IE conducted search operation in the general area of Pangei Nepali Basti Maning Ching, HNG-PS, IE.

That, during the search operation one White plastic sack was found abandoned and conceal at the ground near the foot hill of Pangei Nepali Basti Maning ching. On being suspicious, the sack container was checked and found huge arms and Magazines suspected to be looted from different Armed Battalions. The abandoned arms and magazines are seized u/s 102 CrPC at 04:00 pm from Pangei Nepali Basti Maning Ching, I.E by observing necessary formalities.
