



Subject :- Request to file FIR against Miscreants for destruction and looting of property.

Sir,

In inviting a reference to the above cited subject above, I have the honour to report that on 06 and 7<sup>th</sup> May, 2023 due to communal violence spread across Imphal valley towards the Kuki-chin-Mizo tribe by some radical sections of majority valley based organization namely Meetei Leepun and Arambai Tengol, my house located at Lamlongei (Vaiphei Veng) Mantripukhri have been at the receiving end of most inhuman activities by the radical mob. On 6 and 7<sup>th</sup> May, 2023, volunteers believe to be from the aforementioned radical organization attacked, robbed and destroyed the colony including my house.

Since, the incident was very sudden, we had no time to packed anything including important documents and valuable items nor could we file an FIR at police station earlier. In the process they have looted all valuable items including cash, documents and jewellery, later they destroyed and burnt down various items in and around the home compound. Details of property affected is enclosed as ANNEXURE-I.

In this regard, i am to request you to kindly take up further necessary legal actions against those miscreants involved in theft and destruction of property.
