I have the honour to state that on 04/05/2023 (Thursday), at around noon; unknown miscreant suspected to be Meiteis trespassed into my house noted below and broke open my iron gate and then made their entry inside my house by breaking my front door and had stolen away all my properties. I took shelter at IGAR (South) camp for quite some time and then I was evacuated along with many others to Kangpokpi and then I am now taking shelter at Senapati. Recently, I came to know that my house (RCC building) was also burnt down by unknown miscreants. The following properties were either stolen or burnt down after ransacking and vandalizing my house.
