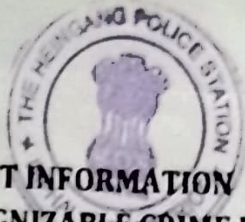

Subject :- Report on looting, Vandalism and its properties.

Sir,

I am to report that on the 3<sup>rd</sup> of May, 2023 at about 6:00 pm, my residential home, owned and registered in my name bearing Patta No. 63/311, Dag No. 351 under Revenue Village No. 7 Lamlongei, situated at Catholic Colony, Mantripukhri, Imphal West, was attacked by Meitei miscreants.

The criminal broke open the gate and destroyed my residential semi pucca house at location mentioned above. Properties inside my residential house, which were looted and vandalized by the said Meitei miscreants are as below :-

1. One Maruti Suzuki Alto car bearing No. MN01AW-0474 worth Rs. 500000/-
2. Two-wheeler Activa B/No. MN06SC- 7151 worth Rs. 90000/-
3. Sofa set worth Rs. 150000/-
4. Seven Bed worth Rs. 300000/-
5. 9(nine) wooden Almirah worth Rs. 200000/-
6. One Refrigerator worth Rs. 55000/-
7. Washing machine worth Rs. 12000/-
8. Kitchen Almirah, dining table, kitchen cabinet worth Rs. 100000/-
9. Gas cylinder (5 Nos) worth Rs. 12000/-
10. Gas stove worth Rs. 4500/-
11. Jewellery worth Rs. 25000/-
12. Clothing, bags, trolley, shoes, accessories worth Rs. 1000000/-
13. Smart TV worth Rs. 15000/-
14. Food grain worth Rs. 90000/-
15. Solar plate (2 in Nos) worth Rs. 100000/-
16. Battery (2 in nos) worth Rs. 100000/-
17. Kitchen items/utensils/oven, etc Rs. 1000000/-
18. Mattress worth Rs. 300000/-
19. Syntax worth Rs. 25000/-
20. Miscellaneous worth Rs 500000/-
21. Building and land value Rs. 15000000/-

The total loss is estimated to be Rs. 20456000 (Rupees Two crore Four Lakh Fifty six thousand) only. Fortunately, all family members managed to escape from the criminals.
