With due respect I am to report that on 03/05/2023 I along with my younger brother Limminlen Baite escaped from our rented room, owned by one Mr. Sehkam Dimngel, at Phainom Veng, Mantripukhri, Imphal East, due to the communal attack by Meitei miscreants and took refuge at 2<sup>nd</sup> MR campus.

That, as per information our rented room has been vandalized and looted of all our properties since 4/5/2023 around 12.20 pm.

The list of properties are as below :-

1. Aprilia storm scooty B/No. A/F (brand new), worth Rs. 120,000/-
2. Syntax 500 ltr Rs 3000/-
3. Laptop (dell company) worth Rs. 40,000/-
4. One gas cylinder and stove worth Rs. 4000/-
5. Clothes worth Rs. 8000/-
6. Total amount Rs. 175000/-

It is therefore requested to kindly take up neccy legal action against the unknown culprits.
