It is learnt that today i.e. the 29/05/2023 at about 02:40 pm to 04:30 pm, a gang of Meitei community numbering about 2000 (two thousands) attacked suddenly to Beulaland village under Kangpokpi District, Manipur dominated by Kuki, Schedule tribe consisting about 10 houses in which all the houses were burnt down and gutted in fire. Further the gang proceed to Bongyang village under Kangpokpi District, dominated by Kuki, schedule tribe consisting about 40 houses in which all the houses were also burnt down and gutted into fire and there was some exchange of gun firing on both sides.

After commission of the crime, all the culprits disappeared to unknown direction.

Hence, a regular case on suo motto under FIR No. 21(5)2023 TBL-DAM-PS U/S 147/148/149/427/447/435/400/326/395/397 IPC and 25(1-C) A.Act has been registered for the purpose of investigation.
