Subject : Report.

Sir,

I have the honour to state that, on 28-05-2023 at around 6:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1500- 2000 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our village, Twichin village, under Lhungtin Sub- Division Kangpokpi District, Manipur about 30 km East from Saikul-PS and they vandalised my house and looted all the moveable and valuable properties including the domestic animals and burnt down my house along with all the remaining items into ashes leaving us homeless.

Fearing lost of live self alongwith my family left our house and fled to the jungle and hide the whole night without food, water and blanket and as of now we temporarily stayed at Dongsum Relief camp, Saikul Kangpokpi District, Manipur.

The list of properties destroyed or loss are mention in the Annexure (enclosed). The Approximate value of destroyed or loss properties is calculated at about Rs.7,41,350/- (seven lakhs forty one thousand three hundred fifty).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
