Wherein, a large gathering mob of Meitei Community conspired and instigated my Meitei Leepun & Arambai Tenggol of valley base CSO's attacked on my/our K. Vengnom and started vandalizing, ransacking and burnt down our house rendering me in a state of homelessness. Fearing to lose of our lives and being in a state of vulnerability, I along with my family members numbering 2 (male) 01 (female) had fled and now taking refuge and shelter at the resident of Lucha Haokip, S. Muoldung.

That, the assets/properties and damages were estimated to Rs. 3600000/-.

I, therefore, seek your kind intervention to register an FIR against the perpetrator and abettors for their heinous acts carried out against me and my family.
