Respected sir,

We are family of 4 members and we are the residents of the above address since 2021 and it is my personal property. On the 3<sup>rd</sup> May, 2023 at around 11:00 pm, we heard war bells followed by loud blasts. Our locality chief/village authority called for an emergency meeting and advised us to remain clam. We headed to the nearest relief camp in IGAR (S) and were given protection under the Assam Rifles. Later at around 2:00 am a group of Meitei Leepun and Arambai Tenggol came and started burning our house using petrol bombs followed by burning of the vehicles. This attack went on incessantly for about 4-5 hours.

It was clear that the Meitei mob had attacked us with the help of Arambai Tenggol merely because we are Kuki tribal Christians. I was running my business as the special construction contractor.

I own land under patta No. 587, Dag No. 1331. I have incurred property damage of Rs. 4,42,500 including :

1. Main door and back door
2. Whirlpool washing machine – Rs. 30,000.
3. LG Refrigerator – Rs 29,000.
4. Gas stove – Rs. 3000
5. Gas cylinder – 3,500 x3 = Rs. 10,500.
6. Mattress (3) – Rs. 13000
7. Computer set - Rs. 1,20,000
8. Prestige induction – Rs 3,500
9. 3 wardrobes – Rs. 53,000
10. Furniture – Rs. 70,000
11. Kitchen set – Rs. 25000
12. Car wash machine – Rs. 4000
13. Blanket (4) – Rs. 12000
14. Grain bags – (15x 1500) = Rs. 22500)
15. LCD TV – Rs. 47000.

There is no way we can continue to reside in the same locality with Meitei people in the valley. The mental trauma has been deep and agonizing as any sound triggers panic attack and sleepless nights follow me to this day. I wish i could someday have a full night sleep Hence, we request you to restore normalcy and punish the perpetrators of these crimes and provide reimbursement/ compensation of the loss incurred so that we can rebuild our house and live in a safe atmosphere, as we are hoping for justice.
