Sir,

With due respect, I have the honour to state that I have been staying at a rented house near Lamlongei Auto Parking and the house belongs to Archbishop' house, Imphal. On the intervening night of May 3, 2023, at around 9:30 pm unknown mob of around 50-100 people suddenly came and ransacked my quarter and looted whatever I have. We barely escaped with only the clothing we had worn. They looted the furnitures, kitchen wares, computer desktop, printers, fittings and furnishings and destroyed everything in the house. On May 4, they destroyed the doors and windows of the house. They also totally damaged my Omni School Van bearing Regd. No. MN03P7053. The total lost is worth about 25-26 lakhs of rupees.

I regretted for sending this report late as we were in the refugee camp where there was no facilities for paper, pen and envelope.

I, therefore you to kindly investigate the matter and compensate us for all the losses. For which act of kindness you have shown to me I shall ever be grateful to you.
