## Respected Sir.

We are family of 9 members and we are the residents of the above address since 2013 and it is my personal property. On the 3<sup>rd</sup> May, 2023, at around 8:00 pm, we heard war bells followed by loud blasts. Immediately we called OC office of Heingang Police Station and informed them about the situation the authorities told us that they are not in a situation to provide help and security because of the insufficient police force. Therefore, we evacuated women and children from our home and moved them nearby neighbor's house. Later at around 8:30 pm a group of Meitei our house using petrol bombs followed by burning of the vehicles. This attack went on incessantly for about 4-5 hours.

With the help of the army my family was moved to Assam Rifle camp at Mantripukhri around 9:00 pm. Army convoy dropped us till Kangpokpi and from there we hired a vehicle to Shilong and rented a house.

It was clear that the Meitei mob had attacked us with the help of Arambai Tenggol merely because we are Kuki tribal Christians. I was running my business as the special construction contractor.

I have incurred property damage of Rs. 5 crores because I have two houses in the same plot number 635 (Dag No. 804) one was an old house and another one was being constructed which was almost going to finish (The Land Patta is in the name of my mother Mrs. Chongpi). The radicals burnt down everything including construction contract documents. And looted whatever was left afterwards.

I had possessions worth 50 lacs in the house. Royal Enfield Rs. 225,000/- Mahindra Thar Rs. 1500000/- Yamaha RX 100 20000/- Traditional Weapon 1 Musket. All our household items, automatic washing machine, Laptop, refrigerator, 2 sofa set, 6 almirahs, 6 bed sets, dining table set, clothes, wardrobe, are all lost. The mental trauma has been deep and agonizing as any sound triggers panic attack and sleepless nights follow me to this day. I wish I could someday have a full night's sleep.

There is no way we can continue to reside in the same locality with Meitei people in the valley. Hence, we request you to restore normalcy and punish the perpetrator of these crimes and provide reimbursement/ compensation of loss incurred so that we can rebuild our house and live in a safe atmosphere, as we are hoping for justice.
