Respected sir,

We are the residents of the above address since 2013 and have been staying in our house. On 03rd of May 2023, at around 6:50 pm, we were attacked by the Meitei militant so called Arambai Tenggol and Meetei Leepun. So in order to save our lives we rush to 4th Ar Mantripukhri to safe ourselves. After we left our home the Meitei mob along with the radical Meetei Leepun and Arambai Tenggol came with trucks and looted all our properties and belongings which the list are enclosed herewith as annexure I.

We stay in 4th AR Mantripukhri till the 8th of May 2023 and later in the evening of 8th May 2023 being escorted by the army we travel to kangpokpi and stay there till the 10 may 2023. On the early morning of 11th may 2023 we then travel to Dimapur by bus vis guwahati to Shillong on the 12th of may 2023, And currently we are taking a temporary settlement at Lapalang Shilong.

Hence, we request you to restore normalcy and punish the perpetrators of these crimes and restore peace so that political dialogues be held between the stake holders and SEPARATE ADMINISTRATION be given to the Kuki -ZO community as we cannot go back to the Imphal Valley as the hatred and enmity towards our community is immense and brutal and provide us a new home where we can feel safe and secure, as we are hoping for justice.
