It is learnt that today i.e. the 29/05/2023 at about 07:30 pm to 08:30 pm, about 150 (one hundred and fifty) Kuki peoples and suspected to be Kuki armed militants attacked to Laikhong village, Imphal East District, Manipur dominated by Meitei, consisting about 50 houses in which all the houses were burnt down and gutted into fire.

Further the gang also burnt down about 05 (five) houses at Itham village, Imphal East dominated by Meitei and there was some exchange of gun firing on both sides. After commission of the crime, all the culprits disappeared to unknown direction.

Hence, a regular case on suo motto under FIR No. 22(5)2023 TBL-DAM-PS U/S 147/148/149/427/447/435/400/326/395/397 IPC and 25(1-C) A. Act has been registered for the purpose of investigation.
