Respected sir,

We are the resident of the above address since 2008-09 on the 3rd of may 2023 the house and all the properties in it including a small business setup, four wheeler and a two wheeler, where burned down to ashes by the Meitei mobs. Around 8:00pm we heard the mob coming and in order to save our lives, the whole locality rushed inside the HQ IGAR camp in Mantripukhri as it was adjacent to our house. After a short while around 8:30 pm they started burning down our houses. The Army gathered us in a quite place and from the place we were sitting we could see and hear the burning of house, blasting of gas and vehicles. I saw my house burning into flame with my own eye. After a short while the army evacuated us in a huge hall there were thousands of people. The army provided us foods and supplies. Me and my family stayed therefore 2 days and after that the army personally evacuated us and safely drop us at Sapermeina, Kangpokpi Dist relief camp on the 5th of may 2023. We stayed there till 10th of may 2023, on the 10th May afternoon we took a route to Dimapur by Bus from kangpokpi. After reaching dimapur, KCC Church member gave us a place to rest and stayed there for a night and booked a train ticket for the next day. Dimapur – Guwahati.

On the next day i.e. 11th of May 2023 we started our journey. After reaching Guwahati we booked an Uber and reach shilling save and sound by the Grace of god at my uncle place.

 - 6) Kitchen items (Approx-Rs. 2 lakhs)
 - 7) Clothes (Approx-Rs. 4 lakhs)

We are hoping for Justice for us and foll all who are in this situation and to book the culprits as per sections of the law.
