Respected sir,

We are the resident of the above address since 2016. On the 3rd may 2023 the Meitei Arambai tenggol with Meitei leepun attacked our locality and I along with my two kids had to flee for our lives. They attack us sole because we belong to Kuki tribe and want us to stay away from the valley.

I am a widow working in 9 IRB- Mahilla Kuman Lampak as a police constable.

And my two kids are still very yound. We left for Shillong on 9th May 2023 with the help of my relatives. As we came out abruptly we did not bring any belonging with us. We have suffered tremendously, the estimated property that the Meitei miscreant damage amounted to Rs. 50 Lakhs. Vehicle 80,000, household appliances 2 lakhs, electronics appliances Rs. 11 lakhs etc.

I ahve suffered a lot mentally due to this situation therefore, I request you to restore the situation to normalcy and compensate me for my lost. And book the culprits as per section of law.
