Today i.e. 03-08-2023 at @ 5:50 pm an unruly mob numbering about 400-500 individual abruptly throng at the main gate of Heingang-Police Station Imphal East with an intent to snatch/loot service arms and ammunition. Acting swiftly, I along with the available personnel of Heingang police stopped them from entering inside the Heingang-PS campus gate. Immediately I intimated the matter to police control room/IE (Oscar-50) through WT msg for reinforcement.

The unruly mob shouted and pushing to open the main gate of the PS and to handover every service arms and ammunition to them. I requested as well as warned them to disperse else a reasonable force would be used against them. Despite continuous request and warning the unruly mob started pelting stones inside the campus and police personnel in which two vehicles i.e. B/Reg. No MN 01 W-7238(ASTAR car), B/No. MN06-9182 (Swift car) and window glass of OC quarter were damaged by the unruly mob.

That, to disperse the unruly mob the personnel of Heingang-PS as well as reinforcement teams fire several tear gas shell and stun grenade (smoke bomb) as well as fired live round in the air to disperse them away.

That, the unruly mob was dispersed completely at @ 07:10 pm by using minimum and reasonable force. No individual from both side was injure during the incident.

Hence, a regular case has been registered under FIR no. 229(8)2023 HNG-PS u/s 147/148/149/427/506/511 IPC & 3PDPP Act 1984 on suo-motu for investigation.
