Subject: report

Sir,

I have the honour to state that I have investigated an U.D. case 11/HNG PS/2023, dated 27/06/2023 u/s 174 CrPC on the basis of suo-motu that on 27/06/2023 at 09:00 am, received an information that on the same day at around 08:50 am, one unknown male dead body was found lying at the Nepali Basti, Iren Kachin Lok, Pangei. Hence the UD case.

In the course of investigation, inter alia, visited the spot along with Executive Magistrate namely M. Tomcha Singh, SDC Sagolmang and Mobile Forensic team led by Dr. RK Sunanda and conducted inquest over the dead body. During inquest, the dead body was found wearing one T-shirt round neck with logo of Mickey Donald, one dark blue Jean with logo U.C.B, one black thread wrapped on the left Ankle, black half pant with a logo of D.S. Height 5'6', external injury can't be established as the dead body was in the advance stage of Skeletonization. Further, Seized 3 (three) Nos. vials of suspected brown sugar and one syringe. Deposited the dead body for post-mortem at JNIMS Morgue. The identity of the dead body couldn't be established till date despite wide publication in local Newspaper and electronic Media published in the state on 28/06/2023 besides dispatch a message to all OsC in Manipur. On 05/07/2023 conducted post-mortem on the dead body by the Dr. Meghachndra Wangkheirakpam, Senior Resident Dept. of Forensic Medicine and Toxicology J.N institute of Medical Science Porompat. On 07/07/2023 vide order No. DM(IE)/5/10/97(Pt-II) the dead body was disposed (buried) by IMC at Mantripukhri Hindu Crematorium complex Mantripukhri. Received the P.M examination report from concern Department and opined that the death could be due to firearm injury to the head and Homicidal in Nature. Since, the deceased is suspected to be murdered by unknown persons which tantamount to an offence under section 302 IPC, the present U.D. case is required to be converted in a regular case for proper investigation.

It is therefore requested kindly to take up necessary step into the matter.
