Subject : Report

Sir,

I have the honour to state that on 28/5/2023 at around 4:00 am about 200 unknown armed Meitei locals of neighbouring villages carrying deadly weapons came towards Semol Kuki village and attacked the Kuki villagers by indiscriminate firing. At that time local public of Semol and neighbouring villages also gathered near the paddy field of Semol village and defended the attackers by using licence guns. Seeing the situation the Central Forces deployed nearby the area came and in order to control the situation the security forces started firing indiscriminately in that area and controlled the situation. At about 05:00am of the same day my elder brother namely, Songkholen Guite aged about 36 yrs s/o Vangkam Guite of Pashong village, Ukhrul District, Manipur and his friend namely, Mr. Lungougin Haokip (21) yrs s/o Hemkholal Haokip of Songphel village, Ukhrul District and Mr. Thangjalen Chongloi (25) yrs s/o Satkhomang Chongloi of Twisomjang village who were village volunteers and stationed at Semol village under Lhungun Sub-Division Kangpokpi District, Manipur were found death at the paddy field in between Sanasabi village and Semol village under Yaingangpokpi-PS, suspected to be killed by unknown persons suspected to be armed Meitei Public and Central Security Forces. The three dead bodies were collected by the local public and buried in their respective villages by observing funeral service as per Kuki customary rites. However, I could not report the incident timely to the concerned authority because of misunderstanding among the local public and lack of legal knowledge since the deceased were killed in the prevailing communal conflict of Manipur.

I, therefore, request you to kindly register a case and take up necessary legal action so that justice is served to the bereaved family.
