It is learnt that today i.e. the 30/05/2023 in between 06:30 am to 08:20 am, a gang of unknown valley youth (Meitei community) numbering about 4000 (four thousands) suddenly attacked at Saichang village, Kangpokpi district, dominated by Kuki consisting about 50 houses in which all the houses including 01 (one) Church burnt down and gutted in fire.

Then, the gang proceed to Songphel Kuki village and burnt down about 15 houses including 01 (one) Church and another village L. Molnom village consisting about 20 houses including 01 (one) Church were also burnt down. Further the gang proceed to Molkonbung village and burnt down about 30 houses including 01(one) Church and another village Chaningpokpi were also burnt down about 20 houses and gutted into fire. Further learnt that there was some exchange of gun firing on both sides.

Hence, a regular case on suo motto under FIR No. 23(5)2023 TBL-DAM-PS U/S 147/148/149/427/447/435/400/326/395/397 IPC and 25(1-C) A. Act has been registered for the purpose of investigation.
