



Sir,

I have the honour to report to you for kind consideration that, due to unavoidable circumstances I cannot report on time. However, I humbly request for your kind entry and look into the matter.

That, on 6th May, 2023 at around 06:30 am thousands of mobs from the Meitei community carrying deadly weapons, attacked and ransacked my house at K. vengnom near IGAR South Gate, Khabam Lamkhai, Mantripukhri. And they also looted all my household properties.

Details of destroyed house/looted items :

Semi Pucca House Almirahs, Beds Sofa set, Benches, Table, Smart TV Set (Flat), Washing machine, Gas stove, Gas Cylinder, Refrigerator, utensils, clothings, documents etc. even household electric bulbs, fans and all electronic items were also looted. All valuable/invaluable items in the households were completely destroyed.

The approximate value of total losses in ₹ 9,50,000/- (Rupees Nine Lakhs & Fifty thousands)

I therefore request to booked the culprit and take necessary action as per the law of the land.
