Respect Sir,

I had newly purchased the land and build the house in the year 2014 after the death of our father. On hearing about the incidents around our locality due to fear of losing our lives we moved to the Catholic Church nearby for a day and then the Assam Rifles provided us shelter in their camp for 3 days, later we were shifted to Kangpokpi District Relief camp for 7 days. From there we escaped to Shillong on 10th May. After we moved there we got to know on 28th May, 2023 that our house had been vandalised and burnt down by Meitei Leepun Arambai Tenggol. The property was our own build by me for which the land costed Rs. 20,00,000/- and had costed Rs. 10,00,000/- for construction and is now worth Rs.40,00,000/- and had items worth Rs. 10,00,000/- and jewellery worth Rs. 15,00,000/-. We were in the process of re-entitlement of pension for my sister, but now that has been put on halt because of our displacement and we are not able to do any paper work. Due to this we went through a lot of mental trauma were traumatised.

I and my family were targeted because we were from the Kuki Tribe and we no longer have a home to stay. I had been working in a private clinic and no longer have a job nor salary. I was earning Rs. 12000/- a month. I being the eldest in the family I was supposed to even support my sister but now our future is uncertain.

Due to the displacement, me and my family have gone through terrible losses financially and are suffering from mental trauma and are left with no hope right now.

Hence, we request you to restore the situation to normalcy and help us get financial help to build my home back, protect my property back in the village from encroachment and help me settle back to the place where I have grown up and been for most part of my life.

We are hoping for justice for us and all our people from this situation.
