Subject: Complaint regarding destruction and demolition of Believers Eastern Church building cum residence, personage and properties of the church at Pangei Lairam Mapal Makha Leikai, P.O. Pangei, P/S. Heingang. Imphal East District, Manipur-795114 on May 3 & 4, 2023, at 8 PM and 1PM irrespectively.

Respected Sir,

I, on behalf of Believers of Believers Eastern Church, Pangei Lairam Mapal, have the honor to report and file a police complaint that amidst the violence and arson that spread through Manipur, on May 3, 2023, at 8: 30 PM, a group of approximately 3000 people came to the church premises and attacked and destroyed our Church building cum my residence, parsonage Wall, assets and properties of the church located in Pangei Lairam Mapal Makha Leikai P.O. Pangei, P/S. Heingang. Imphal east District-795114.

The mob was armed with spades, axes, sticks, and other deadly weapons, and they broke down the door of the church, defiling the sanctity of the place of worship and completely demolished the church building cum my residence, personage and properties causing damage worth Rs. 75,50,000.00 (Seventy- five- Lakhs and Fifty-Thousand) only. During the attack, the mob also verbally abused the Christians and threatening them to abandon their faith and return to their original religion.

This is a detailed description of the monetary loss that we suffered:

Apart from this loss that I have already suffered due to the absolute breakdown of law and order in our state, I am also being threatened or renounce Christian faith and accept the indigenous faith.

As, I was falling sick and also have some apprehension about other consequess. I was not able to report about the matter on time and thereby delay to filed the report. You are thereby requested to Register an FIR and submit the computation of the loss to our property metioned here, to any appropriate body of the state government to grant us the compensation that we need to rebuild our lives.
