I the undersigned would like to lodged an FIR at your good office for further necessary action at the earliest.

That, on 5th June, 2023 at around 8:00 PM my son namely Thangsamir S/o Ginminlun was forcibly pulled out from our house located at Mercy Lane, Mantripukhri, Mannipur and was beaten black and blue and later killed by unruly mob belonging to Meitei Community suspected to be volunteers of Arambal Tenggol, Meitei Leepun. They vandalized my rented house and looted our clothes, kitchen items, household belongings etc. We flee from the locality to save ourselves as it is not safe to stay any longer.

I could not report the matter in my concern Police station and in time due to the prevailing situation of the state.

I therefore requested you to kindly registered an FIR and take up legal necessary action at the earliest.
