I the undersigned would like to state few lines for your kind consideration and sympathetic action please that on 7th May. 2023 at around 11:00AM, Meitei organization numbering more than 500 (five hundred) carrying sophisticated weapons forcefully entered our rent house and looted our properties at Catholic Colony, Lamlongei, Mantripukhri, Imphal East, Manipur under Heingang | Police Station.

The properties looted and destroyed includes:
