**Subject : Report on looting of properties from residential quarter located at No. 105, 7<sup>th</sup> Manipur Rifles, Khabeisoi, P.S:- heingang, District – Imphal East and discrimination of Scheduled Tribes.**

Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribes belonging to the Kuki Tribes, which is a recognized Tribe under the constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (prevention of Atrocities) Act, 1989.**

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our residential Quarter located at No. 105, 7<sup>th</sup> Manipur Rifles, Khabeisoi, P.O./P.S. – Heingang, District- Imphal east on the 8<sup>th</sup> of May, 2023 at around 4:30PM, it has to come to our Knowledge that our deserted residence was looted on the 2<sup>nd</sup> of June, 2023, and whereas, the time of looting and the perpetrators remains to be unknown.

That, the criminals broke open my door looting everything from my residential quarter/ premise is worth about Rs.3,81,500/- (Rupees Three Lakhs Eighty- One thousand Five Hundred) only.

I, therefore, requested you to kindly register my case as Zero FIR and taken stern action against the perpetrators under the relevant provisions of the law of our country.
