Sir,

I, the undersigned would like to lay down the following facts before you in favour to take necessary actions, thereof. That, my resident at K. Vengnom which is located just in front of IGAR(S), Khabam, which is registered in the name of Mrs. Heshi haokip, (Mother in law) W/o Ngamthang Haokip, bearing Patta number 688/661, Dag No. 124/919. Which area is approximately 0.0850 acres. The Patta as aforementioned was issued by Heingang SDC/992 on the 5th of September, 2016.

On the 4th May 2023 at around 8 am, unknown miscreants belonging to Meitei community numbering more than 1000 people suspected to be members of Arambai Tengol, Meetei Leepun and other have attacked our locality i.e. K. Vengnom IGAR South, Khabam, Imphal under Heingang Sub-Division by holding deadly weapons including automatic Rifles. The miscreants have ransacked, looted and burnt down my house and all properties like furnitures, kitchen items, clothing, important documents, Grains Rice and other properties inside the house. The estimated value of properties lost and burnt by the miscreants in detail are as follows : (i) Cost of properties- Rs 40 lakhs (ii) cost of Plot- 1 and half Crores (iii) Cost of building 80 lakhs. The total cost is estimated to be around Rs. 2 Crores and 70 Lakhs.

That, I could not report the incident to my concerned police station, as we were on the run and no longer has access to Imphal.

Therefore, I request you to take necessary action at your end. I shall remain ever grateful to you.
