Sir.

I have the honour to state that, on 28/05/2023 at around 03:30 pm some unknown miscreants suspected to be a members of Meltei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meltei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 900-1000 persons carrying sophisticated weapons like AK Rifles. SLR. INSAS and .303 Riffes, forcefully entered our village, P.Phaimol village. Lhungtin Sub-Division. Kangpokpi District, Manipur about 20 Km East from Saikul-PS and and they vandalised my house and looted all the moveable properties including and burnt down my house along with all the remaining items into ashes leaving us homeless.

Fearing lost of live self along with my family left our home and fled to the jungle and hide the whole night without food, water and blanket and as of now we temporarily stayed at Saikul Relief Centre. Kangpokpi District, Manipur. The list of properties destroyed or loss are mention in the Annexure (enclosed). The Approximate value of destroyed or loss properties is calculated at about Rs. 27,42,000 /- (Twenty seven Lakhs and Forty two thousand).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
