Sir,

I have the honour to state that, on 05/06/2023 at around 08:20 pm some unknown miscreants suspected to be members of Meitei youths Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tengol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 500 persons carrying sophisticated weapons like AK, SLR, INSAS and .303 rifles forcefully entered our locality, K. Vengnom near IGAR South, Imphal East District, Manipur about 46 Km south from Saikul PS and they vandalized my house and looted all the moveable and valuable properties and burnt down my house along with all the remaining items into ashes leaving us homeless.

The list of properties destroyed or loss are mention in the Annexure (enclosed). The Approximate value of destroyed or loss properties including the land valuation is calculated at about Rs. 1,11,68,000/- (One crore eleven lakks and sixty eight thousand).

It is therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
