

Dear Sir/Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Schedule Tribe belonging to the ZOU Tribe, which is a recognized Tribe under Constitution of India, by virtue of which I am being entitled to the protection under the SC/ST(Prevention of Atrocities) Act, 1989.

That, I serve under 8th Indian Reserve (commando) Battalion as a constable, bearing No. 8019820, posted at Khabeisoi, PO/PS Heingang, District-Imphal East due to the prevailing ethnic crisis in and around Imphal, I along with my colleagues belonging to the same Tribe, left our above- mentioned barrack/place of posting on the 8th of May, 2023 at around 03:30 pm, leaving behind my personnel belonging along with my Motor-cycle. That, it has come to knowledge after having a video call(Airtel to Airtel) with my colleague on the 17th of July 2023 at around 12:45 PM, I realized that my deserted Motor-cycle is missing from the Battalion's parking lot or the place I last parked at, i.e. 8th Indian Reserve(commando) Battalion, Khabeisoi, Imphal east and to this day, I do not know, nor suspect anybody to be the perpetrators behind my missing vehicle which is worth rs. 1,28,950/-(Rupees one lakh twenty eight thousand nine hundred fifty) only.

I, therefore, requested you to kindly register my case as a ZERO FIR and take stern action in finding the perpetrators along with the said vehicle, under the relevant provisions of the law of our country.
