With due respect and humble submission, I the undersigned who is presently serving in Central Reserve Police Force as Constable (GD) and posted in 86 Bn CRPF, Lamphelpat Imphal West, Manipur would like to submit the following few lines for your kind consideration and favourable action please.

That in the intervening on 5th May 2023 at around 12:00 hrs, some unknown miscreants completely vandalized and looted my house and eventually burnt down my house which was built at my hometown "Bongbal Kholen village, under Maphou, P.S. Island Sub-Division, Kangpokpi District" and take away all my valuable household items/ ornaments which was kept at my house i.e., residential House, Gold ear ring & necklace, Laptop, washing machine, refrigerator, smart TV, Utensils, (04) Godrej steel almirah 4 doors, paddy food grains, livestock, clothing items, blankers, bedsheets, daily wears, baby dresses etc., total cos of above items is approximately Rs.33,31,500/- (thirty three lakhs thirty one thousand five hundred). During the mayhem period family took shelter at the Keithelmanbi Military Colony Kangpokpi District. Keeping in view of above, kindly lodge FIR in this regard as per Law and trace out my valuable items please so that I may be able to perform my duty with dedication and sincerely.
