Subject :- Report for FIR on looted/Vandalized/properties.

Madam,

With reference to the above cited subject, I have the honour to report to you as below:

1. That, I Lamthang Haokip age 47 years H/o Tinkhochong Haokip belongs to the Kuki community, a schedule tribe recognized under the constitution of India. By Virtue of which I am entitle for protection under the SC/ST (Prevention of Atrocities) Act, 1989. Where,by, I am a permanent resident of Khabam Vengnom, IGAR South, PS- Heingang, District Imphal East.
2. That, on 4th May 2023 at 9 pm, a huge contingent of armed Radical Meetei/Meitei Mobs, Arambai Tengol and Meetei Leepun along with state Forces like Manipur Police Commando and Indian Reserve Battalion (IRB) attacked our village and in the process looted/Vandalised properties.
3. That, the above said criminals with their inhuman activities have grave caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs. 35000000 (three Crores and fifty lakhs) only
4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us.
5. Henceforth, we are taking refuge at Changlei Veng (Rent) near Molnom, Lamka
6. I, therefore, request you to register an FIR/Zero FIR and bring justice.
