Sir,

With reference to the above cited above, I, Mr, Cliff Khailun Haokip @ Helen, aged 41 yrs old S/o Khangkhosei Haokip, aged 75 yrs old of K. Vengnom near IGAR(S) Mantripukhri, Imphal (S). would like to report (F.I.R) about the looting of my properties by a mob of people(Meiteis) on the 13 of May, Saturday, 2023 after ethnic cleansing on the Kukies by the Meitei people on th 3<sup>rd</sup> of May 2023 and hence in order to save ourselves, we fled to the nearby Assam Rifle, IGAR (S) Mantripukhri, hurriedly on the 3<sup>rd</sup> May 2023 in th evening when the situation become more volatile. As on haste, we could not bring out anything with us and we even left our land-patta in the file book which was kept in the safe. As, there was no means of returning back we came by truck in Assam rifle convoy on the 9<sup>th</sup> of May to Kangpokpi and on the 13<sup>th</sup> of May, we came to know about the looting of our properties, the dismantling and the burning down of our house from Anil Purkayaskha, a non- Manipuri and married to a Meitei women, who was our neighbor. So, I fervently requested you to study my report(FIR) for the lootings of my properties and burning down of my house by a Meitei Mobs, to the concern authority for swift and legal necessary actions. For which act of your kindness, I shall remain ever grateful to you.
