I, the undersigned would like bring forth to your knowledge and report I, am a permanent resident and native of Koirengai bazaar village P.O & P.S- Heingang- Mantripukhri, Imphal East Manipur and that because of the ethnic conflict prevalent in the state some unknown well- armed miscreants belonging to the Meetei/ Meitei community on being targeting our village and its villagers to defense and security from the state Government leaving us hapless. On the being feared for our life, I along with my family members deserted our village on 7th May 2023 at 6:30 pm.

The total estimated amount of all the assets that was left behind at the mercy of the above mentioned well-armed Meetei./Meitei miscreants is worth Rs. 20,00,000.

I, therefore kindly requested you to please take action in this matter and come up with positive solution.
