

Subject :- Report on crimes of looting and vandalism of properties/Discrimination of Schedule Tribes.

Respected madam,

With reference to the above cited subject, I have the honour to report to your good office as follows:

That, I Neicy Kholneihing Kilong aged about 48 years w/o (L) Bonny Kamkhosat belonging to the Any Kuki tribe/community, a schedule tribe under the constitution of India. By Virtue of which I am being entitle for protection under the SC/ST (Prevention of Atrocities) Act, 1989.

That, I would like to inform and register a cognizable offence carried against me and my family at our owned house located at mantripukhri, Phainom, Imphal West, PS- Heingang.

That, on 28<sup>th</sup> May 2023 at 3:00 pm, a huge contingent of armed Radical Meetei/Meitei Mobs, suspected to be Arambai Tengol and Meetei Leepun attacked our locality and in the process they broke the gate/door open, looted and vandalized the properties from the said deserted resident.

That, it may be reported here that above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated (approx) to be Rs. 20,00,000 (Rupees Twenty Lakhs) only.

Fortunately, I managed to escaped from these criminals who even tried to kill or burn us alive and now currently taking refuge at Taitah Kaprang, PO PS Churachandpur Dist- Churachandpur, Manipur.

I am filing this report lately since I have been at different places for safety. Now, since I am able to settle myself at the above mentioned address, I am in a position to file a report today. Hence, prayed that my report be accepted.

In the given circumstances, I humbly pray you to kindly register a Zero FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of the land. And, for which act of kindness, I shall always remain thankful to you and obliged.
