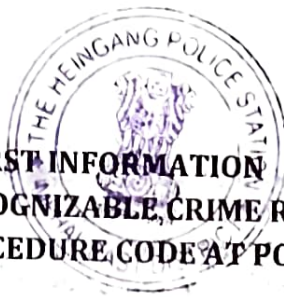

Subject: Report on crime of vandalized and looting of properties/ discrimination of Scheduled tribe.

Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduler Tribe belonging to the Zou Tribe, which is recognized Tribe under the constitution of India, by virtue of which I am being entitled to the prepetition under The SC/ST(Prevention of Atrocities) Act 1989.

That, due to the revealing ethnic crisis in and around Imphal, I along with my family left our resident at Khabam Mantripukhri, PO/PS- Heingang District Imphal East on the 3rd of may 2023 at around 4 pm, it has come to knowledge that our deserted house was attacked, destroyed and looted by a group of radical Meitei/Meitei suspected to be members of Arambai Tengol and Meitei Leepun on the 10th of July 2023 at around 5 AM/PM.

The criminal broke open my door, destroyed and looted every vulable property from my house/premises worth about Rs. 3,00,00,000/- (three crore rupees) only

That it may be reported here that the miscreants were shouting slogans like " KANGLEIPAK YAIPHARE", "KUKI HATLO", "HAO HATLO" : etc. which they were carrying out their criminal activities. It seems to me that all thses has taken place at the instance of the Manipur Stat Government as the perpetrators openly claimed and shouted that nobody would stop them, even the Police because everyone, including top officials if the Manipur Government are patronizing them and that no harm could me done to them.

I, therefore, requested you to kindly register my case as ZERO FIR and take stern action against the perpetrators under the relevant provision of the law of our country.
