I am to bring your notice that on the 4<sup>th</sup> of May 2023 at 8-9:00pm a church building located at Luwangsangbam Awang Leikal, Manipur, I/E owned by Mizoram Presbyterian Church Synod Manipur Area. Aka Tangphai Prebyterian Church was attacked, destroyed, looted and burned by a group of Meeteis/Meiteis.

These Criminals broke open the gate (s), destroyed and looted every valuable properties from the premises which is worth Rupees 20Lakhs (Approx.) and they burnt down all the remaining things.

Therefore, with utmost respect I request you to take strong action against the perpetrators by registering an FIR under relevant sections of the Indian Penal Code.
