Sir,

I have the honour to state that on 28/05/2023 at @ 01: 30 PM some unknown armed militants attacked by firing several rounds ammunition to our Hon'ble MLA of 7 Andro A/C along with his escort team with sophisticated weapons in between L. Molnom and Laikhong village road while coming from Yairipok side to inspect Panam Higher Secondary relief camp at Molrangpurel. During the attacked one bomb was exploded which was already planted there. In this situation our teams retaliate by firing several rounds of ammunitions. The following ammunitions were fired:-

- 1. AK 47 -72 live rounds
- 2. 5.56mm 48 live rounds
- 3. MP5- 19 live rounds

After retaliate by our teams the unknown miscreants disappeared to unknown direction and one Rakshak BP vehicle used by escort team was partly damaged during the incident and no casualties from our side and our team proceed to Moirangpurel.

So, you may kindly take up necessary legal action against the culprits.
