**Subject : Report for FIR on looted and Vandalized properties at my Rented House.**

Madam,

With reference to the above cited subject, I have the honour to report to you as follow:

1. That, I Pokhomang Misao 47 years of age of Panthoibi Lampak belongs to KUKI Community, a Schedule Tribe recognized under the Constitution of India. By Virtue of Which I am entitled for protection under The SC/ST (Prevention of Atrocities) Act, 1989. Whereby, I had stayed at a rented house owned by Mutum Babita for more than 10 years located at Panthoibi Lampak under Heingang PS, Imphal East.
2. That, on 5<sup>th</sup> May 2023 at 7:00 PM, a huge contingent of armed Radical and Meitei Mobs, Arambai Tengol and Meitei Leepun along with State Forces like Manipur Police Commando and Indian Reserve Battalion (IRB) attacked our house and in the process looted, vandalize and burnt my properties in the open field at saban.
3. That, the above said Criminals with their inhumane activities have caused me grave mental agony. Not with standing the fact that, their unruly activities have made loss enormous wealth estimated to be Rs. 16,83,500/-
4. Fortunately, me and my family narrowly escaped from these Criminals who even tried to kill us.

Henceforth, we are taking refuge at Mantripukhri Assam Rifles camp and later, we were evacuated to Churachandpur with the help of Indian Army.

I, therefore, request you to register a zero FIR and bring justice.
