Sir,

I have the honour to state that, on 30-05-2023 at around 06:00am some unknown miscreants suspected to be a member of Meitei Youth Organisations, Meitei Leepun, Kangleipak kanba Lup (KKL)/ Arambai Tenngol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000 persons carrying deadly weapons forcefully entered our locality, K. Vengnom Mantripukhri IGAR South, Lamlongei, Imphal East District, Manipur about 46Km South from Saikul- PS. They vandalised my house and looted all the moveable properties like furnitures, Electronic Gadgets and appliances, Utensils, Clothes, Kitchen wares, building material and Books etc. The list of properties destroyed or lost are mentioned in the Annexure (enclosed). The approximate value of lost property is including the land value is calculated at about Rs. 1,12,98,000/- (one crores twelve lakhs ninetyeight thousand) only.

It is therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
